



This Pop-Up waste is to be installed by a licensed plumber in accordance with local regulations

To the Installing Plumber:

A conventional basin plug and waste has the potential to leak between the waste and basin which can cause water damage to the vanity cabinet. Any sealing issues found during installation would traditionally appear as leaks under the underside of the basin or into the vanity itself. In contrast, the design of our waste ensures that any water leaks will run directly into the 32mm to 40mm outer housing and into the S&P trap regardless of whether the leak comes from the waste housing seals or the internal pop-up seal.

As a natural consequence of this improved design against water escape, any leaks which occur due to the upper waste seal not being sufficiently secured will not be able to enter the cabinet space and may give the impression that the pop-up seal is not working or may make it difficult to pinpoint whether the waste has sealed if the basin is not holding water. To easily overcome any potential issues and to effectively eliminate any chance of leaks, use a plumbing grade silicone on the top and bottom of both upper sealing washer and lower sealing washer which will ensure the waste is fully sealed against the basin surface.

1. Apply a light bead of plumbing grade silicone to both sides of the Upper Silicone Seal and fit into the basin waste hole.
2. Apply a light bead of plumbing grade silicone to both sides of the Lower Silicone Seal and fit against the underside of the basin.
3. Screw on the outer waste housing onto the male threaded waste body, allow the silicone to dry and check the basin holds water / is watertight.

CARE & MAINTENANCE

Avoid using abrasive or acid based cleaning products.

WARRANTY:

This Pop-Up Waste is warranted to be free from manufacturing defects for a period of: 1 Year, Finish, Parts, seals and labour.

This warranty does not cover against normal wear and will be voided if the product is misused or not installed in accordance with these instructions.

In the event this product is rendered obsolete and a replacement product is required.
